Holdings Ltd. operating as Jack's Boat Yard to return the vessel to the water for any period of time, for any reason whatsoever, including the negligence of G.C.R.D. Holdings Ltd. operating as Jack's Boat Yard. I have read and understood and agree to the terms of the above WAIVER OF LIABILITY and will comply with the shop and yard rules.

G.C.R.D. Holdings Ltd. operating as Jack's Boat Yard – Lift Agreement and Yard Rules

1. EVERYONE, including all employees and fishermen, owners and guests, performing work on these premises, must conform to the rules of the yard and be governed by relevant Government regulation, including the Workers' Compensation Board, Industrial Health and Safety Regulations, Ministry of Environment Regulations and Waste Management Regulations, to name a few.
2. G.C.R.D. Holdings Ltd. operating as Jack's Boat Yard does not assume any liability whatsoever for damage to the vessel or contents while in its possession, **including sling damage** or any damage caused by cold weather or freezing to the vessel, equipment, tanks or contents. G.C.R.D. Holdings Ltd. operating as Jack's Boat Yard shall not be responsible for the continuous supply of electrical power to any vessel. G.C.R.D. Holdings Ltd. operating as Jack's Boat Yard is granted permission to operate/move the vessel for testing or inspection, lifting launching or mooring. G.C.R.D. Holdings Ltd. Operating as Jack's Boat Yard has no obligation to inspect, provide maintenance or repair to stored vessel or covering.
3. Good housekeeping must be observed and discarded material must be placed in the disposal containers provided. If the designated area is not cleaned prior to launching, the vessel will not be launched or the vessel owner must pay the cost of cleaning.
4. Any person observing what appears to be unsafe or harmful condition or act should report it to a Jack's Boat Yard employee.
5. G.C.R.D. Holdings Ltd. operating as Jack's Boat Yard is not responsible for loss or damage to the vessel or articles left in or attached to the vessel as a result of fire, theft, accident, vandalism, spray painting and acts of God, nor for liability to owners, crew, guests, etc., whether working or visiting the yard premises.
6. G.C.R.D. Holdings Ltd. operating as Jack's Boat Yard will not assume liability for work or repairs performed by any service person, contractor, mechanic, friend, or acquaintance on any vessel that is not contracted to Jack's Boat Yard signified by a work order that has been filled out and signed by the vessel owner, agent or master.
7. Jack's Boat Yard is pleased to undertake ship repairs that are the subject of insurance claims, but the responsibility for payment of our accounts is that of the vessel owner, agent or master, and our accounts may include insurance claims, hauling, storage, repair costs, parts and labour, relocation costs, cleanup, rentals, disposal of garbage and hazardous waste, launching and moorage. No vessel will be launched until Jack's Boat Yard has received payment in full.
